Acting as a Direct Customs Agent.

When a customs declaration is submitted by Executive Freight Services on your behalf, we are representing you with Customs. This is outlined in section 21 of the Taxation (Cross-border Trade) Act 2018.

Here at Executive Freight Services, we make customs declarations on behalf of the importers / exporters of goods, as a Direct Customs Agent, unless instructed otherwise.

In order to act as a Direct Customs Agent, we must hold written authority that we have been given authorisation by the represented party to submit declarations on their behalf. To standardise this process, we are asking importers to complete our simple Customs Agent form. The form accompanies this document.

When acting as a Direct Customs Agent, we act in the name of and on behalf of the principal (usually the importer/exporter). As a party being directly represented with Customs, you maintain liability for the accuracy of the information declared and for any customs debt that may be incurred at the time of declaration.

As a Direct Customs Agent, we retain responsibility for ensuring the declaration is made in accordance with the instructions provided by the importer or exporter for the declared goods.

Please be aware that we as an agent can only directly represent businesses that are established in the UK. A UK establishment exists if:

- The place where essential management decisions are made, and the business's central administration is carried out, is in the UK.
- The business has a permanent physical presence with the human and technical resources to make or receive taxable supplies in the UK.

We ask that the Customs Agent form is completed in full and returned to us by email at CDS@executivefreightservices.co.uk at your earliest availability. If we do not hold a copy of the form, then we cannot make a customs declaration on your behalf.

Your completed form will be kept on file, should it ever be needed upon the request of Customs.
